Land Development Amendment - Cameltop Mountain Lodge

Nate Oiler, P.E. from RKR Hess Associates was present to represent the applicant, CBH20 LP. A Development Agreement is being prepared in coordination with Solicitor Weitzmann and Sal Caiazzo, Township Engineer of Hanover Engineering. Additionally, a letter of credit that includes the proposed sewer lateral, will be offered. Mr. Oiler noted that an area in front of the building to provide access for emergency vehicles has been added and the waivers granted last month are noted on the plan. Also, a Sewage Planning Module has been submitted to the Planning Commission for the change from onlot disposal to the planned sewage treatment utilizing the Camelback Wastewater Treatment Plant. Mark Major made a motion to grant the waiver for the outer buffer dimensional requirement to the wetland and stream as set forth in the Stormwater Ordinance, being Ordinance 2009-100, for construction of a driveway. Motion seconded by Donald Kresge, Sr. All voted aye. Motion carried.

Monroe County Conservation District – Letter of Support:

Mark Major summarized the nature of the project. The Conservation District will be seeking a LSA Grant for a project on the game lands intended to abate the soil erosion into the Pocono Creek at the site of the old railway crossing. Solicitor Weitzmann added that the Conservation District will be the applicant for this grant. Mark Major made a motion to have a letter of support prepared for the grant application. Solicitor Weitzmann will prepare a letter to Dan Henning of AC Henning Enterprises regarding responsibility for maintenance of this private road. There was some discussion about stormwater runoff.

Solicitor Weitzmann explained a letter received by Attorney Richard Deetz describing a donation from the estate of Kendall Cramer intended to be given to Central Pocono Ambulance. Since Central Pocono no longer exists, a judge ordered the money be given to West End Ambulance as a substitute beneficiary. It is believed West End Ambulance was acquired by Lehigh Valley Health Network however. There was some discussion about the intent of the donation. Pocono Township Volunteer Fire Company already did receive a \$5000 donation from this estate. Lester Wolcott made a motion to have Solicitor Weitzmann draft a response that promotes Jackson Township Volunteer Fire Company as the beneficiary. Motion seconded by Mark Major. All voted aye. Motion carried.

Zoning Officer Michelle Arner advised the final draft of the proposed Short-Term Rental Ordinance has been prepared. After some discussion, Lester Wolcott made a motion to have the planning commission provide comments on the proposed ordinance. Motion seconded by Mark Major. All voted aye. Motion carried.

Lester Wolcott made a motion enter into executive session to discuss a personnel matter. Motion seconded by Mark Major. All voted aye. Motion carried.

Lester Wolcott made a motion enter back into the regular business meeting. Motion seconded by Mark Major. All voted aye. Motion carried.
