Comments:

Friends of HJP Dog Park:

Susan Possinger, Linda Fetter, Kathleen Patten and Vicki Anshou represent Friends of HJP Dog Park. They voiced their concern regarding HJP Dog Park, what is going to happen, maintenance of the Dog Park, parking – Will the township fund the park now that the other townships no longer are a part of HJP??

The Supervisors advised they will do their best to keep HJP Park and the Dog Park maintained. Just recently the Jackson Township Road Crew mowed and weed wacked the property. Unfortunately the financial burden will be placed solely on Jackson Township. A grant has been obtained to pave the parking area and a walking trail, the work will be done between now and October 31st. Once that work is completed, Jackson Township's Road Department will pave the remainder of the road joining the entrance to the parking lot area paid for by Jackson Township. Future plans are to revisit the existing plans of the park that was submitted for Grant Money to obtain the land – and revise it if possible. We have to stay within the Grant Guidelines, but our goal is to keep moving forward with the development of the park itself. Unfortunately it will now be 1 township, not 3 to finance the upkeep and future development of the park.

Friends of HJP Dog Park advised they are willing to help in whatever way they can, mowing, garbage removal etc if necessary to keep the Dog Park Open.
