

**Jackson Township Supervisors
Special/General Business Meeting 10/18/18
Minutes**

The Jackson Township Board of Supervisors Special/General Business Meeting 10/18/18 was called to order by Chairman Donald C. Kresge Sr. at 5:00 PM.

Members present: Donald C. Kresge Sr., Lester Wolcott, Mark Major and Solicitor Todd Weitzmann.

Ordinance 2018-102 Volunteer Firefighter/Auxiliary Tax Credit:

Ordinance 2018-102 as presented needs additional language and some deletions. Solicitor Todd Weitzmann will make the changes and advertise the proposed ordinance for adoption at a later date.

Lester Wolcott made a motion to table Ordinance 2018-102 until the December 13th Supervisor meeting. Motion seconded by Mark Major. All voted aye. Motion carried.

Conklin Park – Rinker Road, NO Hunting signs:

Mark Werkeiser will check on signs and advise what is there, what we need etc. NO Hunting signs need to be in place for the upcoming hunting season.

Monroe County Vector Control – Lee Schuler:

Lee Schuler has been in contact with Zoning Officer Michelle Arner in regards to grant money that is available and must be used by the end of 2018 for tire clean up. There is a property “Flowertown” located off Rinker Road that has approximately 350 tires on it per Lee Schuler. Monroe County Vector Control can help to get this cost deferred to clean it up; however, the township is also being asked to help with manpower and equipment.

Lester Wolcott advised he will discuss it with Roadmaster Donnie Kresge; however, he will not commit the road crew or the equipment until he speaks to Donnie due to possible scheduling conflicts. Michelle Arner will contact Lee Schuler regarding the county waste authority’s ability to drop roll off containers on site to eliminate the cost of township dump trucks driving to and from the area to the waste authority.

Job Applicant Interviews:

The Board of Supervisors and Zoning Officer Michelle Arner have gone through the applications, and have agreed on interviewing 6 applicants. Michelle will arrange interview times on Oct.30th & Nov. 1st beginning at 4PM. The hours for this position will be 10AM-3PM, part-time position, no benefits, \$12-\$16 per hr. Sitting in on the interviews will be the Board of Supervisors, Zoning Officer Michelle Arner and Sec. /Treasurer Jacqueline Elliott.
