Vaccinations/Health/Registration

- Vaccination record from veterinarian are attached showing the following vaccinations: Distemper, Hepatitis, Leptospirosis, Parainfluenza, Parvovirus (commonly known as DHLPP or equivalent), Bordetella (known as Kennel Cough), Rabies (1 yr. or 3 yr.)
- Dog(s) are on treatment for hookworm, roundworm, whipworm, heartworm, topical flea & tick control.
- Copy of current dog registration/license with Monroe County is attached.

Fees/Keys

There is an annual registration fee of \$25 for use of the dog park per family. The annual registration fee includes up to three (3) dogs. If a family has more than three (3) dogs, there is an additional fee of \$5 for each dog over three. The fee is payable at the time of registration.

You will receive a key to the park at the time of registration. The key is only good for one year. If you lose your key, there is a \$5 fee for a replacement key. You may not share your key with nonfamily members. If someone outside your family is found in possession of key, they will be asked to leave and your right to use park may be suspended.

You must turn in your key at the end of the year. To obtain a key for the next year, you must fill out a new registration/contract and pay the applicable fees.

Dog Owner's Acknowledgements and Responsibilities

- Users of the dog park do so at their own risk. Jackson Township shall **not** be liable for any injury or damage caused by any dog. Handlers are legally responsible for their dogs, and any injury to other dogs or damage to facilities caused by them.
- Aggressive dogs (dogs posing a threat to human beings or other dogs) are not allowed at any time.
- All dogs must be legally licensed and vaccinated, and shall wear a visible dog license and have vaccination documents available upon request.
- Dogs must be on leash when entering and exiting the dog park.
- Dogs must be under the control of their handler and in view of their handler at all times.
- Handlers must be 16 years or older. Children ages 9 -15 years must be accompanied by an adult.
- Handlers must have possession of the leash for their dog(s) at all times.
- Handlers are limited to a maximum of two dogs.
- Handlers are responsible for removal and disposal of waste.
- Handlers must prevent dogs from digging holes and are responsible for filling them.
- The following are **prohibited** in the park:
 - Dogs barking incessantly;
 - Food (includes treats bones and edible toys) and glass containers;
 - Dogs under the age of four (4) months;
 - Female dogs in heat;
 - Animals other than dogs;
 - Children under the age of 9;
 - Professional training of dogs;
 - Smoking
- In consideration of my use of the dog park, I, the undersigned, on behalf of myself, my guests and my minor child, do hereby release, discharge, and covenant not to sue Jackson Township, its supervisors, agents, volunteers, and employees from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Township. I further agree that if, despite this Release, I, my guest, the minor, or anyone on the minor's behalf makes a claim against the Township, I will indemnify, save, and hold harmless the Township from any litigation expenses, attorney fees, loss, liability, damage, or cost any may incur as the result of any such claim.
- Owner acknowledges and agrees that Jackson Township may suspend or revoke use privileges for any or all of the following: (1) not adhering to the responsibilities listed above; (2) returned checks or non-payment for fees; (3) disorderly conduct; (4) improper sharing of access key.
