CJERP Proposed Regional Ordinance

Board members discussed the proposed CJERP Regional Ordinance. Informal reviews should be received to our office prior to the next scheduled CJERP meeting. The CJERP meeting for March has been canceled. It was suggested to review the proposed Ordinance and explore the Townships status on items listed in the proposed Ordinance.

New Business:

409 North Road - Orange Pavers Corp. - Land Development - JLS Surveying

Jonathan Schupp, P.L.S., S.E.O., was present to represent the land development plan submitted by Orange Pavers/Viktor Kolesnyk. The location for proposed development is 409 North Road (54.6-acre parcel). The proposed development is for a facility that will manufacture landscaping pavers. The operation will take raw materials and produce palletized finished product – to be stored outdoors. A Conditional Use was granted by the Board of Supervisors previously. Sal Caiazzo stated a "Will Serve Notice" from PJJWA is still required. Jonathan acknowledged this and will obtain it. Sherri Hower made a motion to accept the complete submission for review and table. Motion seconded by Mark Werkeiser. All voted aye. Motion carried.

Modern Gas Sales, Inc. - Land Development/Building Addition - Jude Colwell, P.E.

Jude Colwell, P.E., was present to represent the land development plan submitted by Modern Gas Sales, Inc. Two additions, totaling 1,920 sq. ft, to the existing office space are proposed. There is no additional water/sewage increase expected. Michelle Arner stated a building has been placed in which a permit was not obtained. This will need to be addressed. Sherri Hower made a motion to

accept the complete submission and table. Motion seconded by Mark Werkeiser. All voted aye. Motion carried.
