TERMS AND CONDITIONS



WHO MAY EXHIBIT

All vendors must be a legal business entity doing business within the creative industry. All vendors are responsible for obtaining any sales permits needed to operate at Bethel Woods.

USE OF EXHIBIT SPACE

All retail vendors must be selling finished goods. All supplier vendors must provide an interactive experience in one of three approved ways: make-n-take, interactive project/craft experience, or Creator/Influencer appearance. All vendors are responsible for set-up, decoration, display and tear-down of their exhibit space.

PAYMENT

50% deposit is due upon return of signed contract; final payment is due no later than June 1, 2018. Contracts received after June 1, 2018 will require payment in full. Payment may be made via check or credit card. Checks must be drawn on a US financial institution, paid in US dollars, and made payable to the Association For Creative Industries (AFCI). Any fees not fully paid by June 1, 2018 may result in loss of space.

CANCELLATION

Should vendor not be able to occupy contracted space, AFCI must be notified in writing immediately. If cancellation is prior to June 1, 2018, AFCI will retain 25% of all fees paid. If cancellation is received after June 1, 2018, all monies paid will be forfeited. If cancellation is received after August 1, 2018, the full balance will be due to AFCI.

LIABILITY

The Vendor releases AFCI from any and all claims of every sort it may have against AFCI based upon, arising out of, or in connection with Vendor's occupancy and use of the Festival premises, or any action or inaction of any nature of AFCI in conjunction with or related to the Festival. Including, but not limited to: loss; theft; damage; destruction or delay or non-delivery of goods, display materials and other effects; any injury to Vendor, its employees, agents, representatives or guests while on the Festival premises; any damage to Vendor's business by reason of the failure to provide space for the exhibit or removal of exhibit; failure to hold the Festival as scheduled.

INDEMNIFICATION

Vendor agrees to indemnify and hold AFCI and its directors, officers, employees, agents and members, harmless with respect to any and all claims, losses, damages, liabilities, judgments, or settlements, including reasonable attorney's fees, costs and other expenses incurred by AFCI arising or related to the violation or breach of any term or condition of the agreement between the parties or any of the Festival.

CHOICE OF LAW

This Agreement will be governed by and construed in accordance with the laws of the State of New Jersey. The parties hereby consent to the exercise of exclusive jurisdiction by the state or federal courts in the State of New Jersey for any claim relating to the enforcement of, or any rights under, this Agreement.

Vendor space is limited. Applications will be reviewed on a first-come, first-served basis and based on the creative fit with the Festival. AFCI reserves the right to refuse any vendor application.
