

October is Local **Chamber of Commerce Month**

In recognition of the valuable contributions made by local chambers of commerce, Governor Robert Rendell has proclaimed the month of October "Local Chamber of Commerce Month" in Pennsylvania.

Across Pennsylvania local chapters represent no less than 250,000 businesses and individuals, providing local leadership to promote free enterprise and economic development. And that's just what the Pocono Mountains Chamber of Commerce has been doing for more than 90 years.

When the Chamber received its charter in 1910, it was known as the Stroudsburg Industrial Club and focused primarily on dealing with matters of interest in the community and promoting prosperity of the mercantile and manufacturing businesses in the area.

As Stroudsburg expanded, so too did the Stroudsburg Industrial Club and its influence on the community. In 1919, it officially changed its name to the Stroudsburg Chamber of Commerce. In 1932, the name changed to the Monroe County Chamber of Commerce, and in 1948, it became the Pocono Mountains Chamber of Commerce.

Names have changed over the decades but the influence the Chamber has had on the Pocono Mountains region remains constant. Today, PMCC's membership numbers around 1600. The many volunteers who serve on Chamber committees have contributed greatly to the progress and quality of life in the Pocono Mountains region.

As we celebrate Local Chamber of Commerce Month, it's important to keep one thing in mind: by working with the local business community, local chambers of commerce can and do make a differ-
