

The Pocono Mountains Chamber of Commerce Awards Committee has announced the winners of the 2003 annual awards. They are: Frank Schoelch Community Commitment, William Cramer; Citizen of the Year, Steven Jakubowitz; Businessperson of the Year, Eugene Leblond; Humanitarian of the Year, Father Thomas McLaughlin, and Gray Chevrolet Oldsmobile Cadillac of the Poconos ATHENA Award Recipient, In Memory of Coral Washburn.

William Cramer has been honored with the Frank Schoelch Community Commitment Award, recognizing distinguished commitment to the Pocono Mountains community through philanthropic or service endeavors. The award is presented only occasionally at the discretion of the Awards Committee. William Cramer has an extensive list of community involvement with organizations such as The Salvation Army, Kiwanis Club, United Way of Monroe County (Campaign Chairman in 1985), East Stroudsburg University Foundation, PNC Bank and Jacob Stroud Corporation. Boy Scouts of American, Big Brother/Big Sisters of Monroe County, HIV/AIDS Task Force of Monroe County, Monroe County and Pennsylvania Bar

Associations are some of the organizations to which he dedicates his time. Mr. Cramer is a graduate of Ripon College (A.B.) and Villanova School of Law (J.D.). He and his wife Barbara live in Stroudsburg and have two children and three grandchildren.

Steven Jakubowitz is owner of The Legendary Tannersville Inn in Tannersville. Born in Philadelphia, he served on the Philadelphia Police Force from 1960 to 1965, receiving a Commendation for Meritory Service. After owning several businesses in the Philadelphia area, he moved to the Poconos and purchased the Tannersville Inn in the early 70's. His community involvement includes serving on the first Pocono Township Park Board, honorary member of the Pocono Township Volunteer Fire Company. He was President of the Pocono Chapter of the PA Tavern Association, then later becoming President of the state-wide PA Tavern Association and served many years as Chairman of the Board. For 14 years, he sponsored the PA Special Olympics Benefit, worked to get the Monroe County Fire School built and started and was instrumental in getting the Designated Driver Program started in Monroe County. He received the Volunteer of the Year Award in 2003 from the Pocono Mountains Vacation Bureau and was the Grand Marshall in the 2000 Saint Patrick's Days Parade. Of all the awards he has received, he is most proud of the award that he

received from the State on being the first establishment to start glass recycling in Monroe County. His contributions to the community are well known and far-reaching. He and his wife Janice have two children, Steven and Justin.

Eugene Leblond is the President/CEO of Pocono Health System in East Stroudsburg. Mr. Leblond has over twenty years of progressive and diversified management experience in health care. He is involved with many community services such as Chairman for Pocono Ambulatory Services, Inc., Vice Chairman of Pocono Healthcare Partners, Inc., Board of

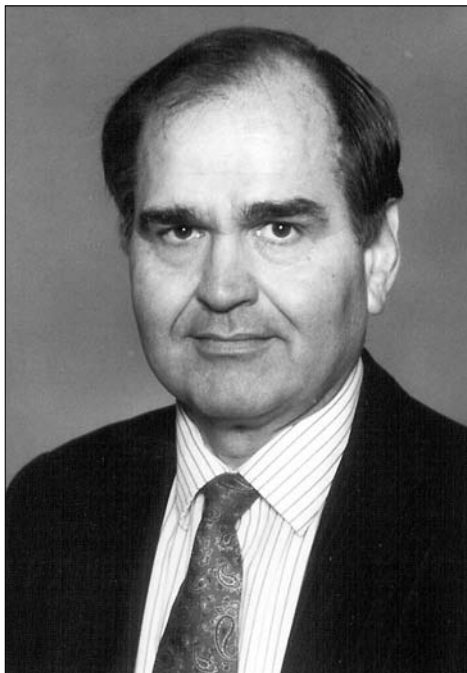
From the Chairman of the Board

Within the last twelve months, there have been three new committees formed at the Chamber. Two were a direct result of strategic planning and the other was started by members who saw a need and were willing to fill it.

In one short year, the Human Resources committee, chaired by Vickie Mavis, has managed to address the needs of both small and large business members. The committee has had speakers at its regular meetings as well as breakfast meetings dealing with compliance issues for employers. The committee also organized the first Human Resources Conference, which was attended by over 110 participants. Committee members saw a need and addressed it, and for that they are to be congratulated.

The Health Care Task Force will be presenting its report at the December annual meeting. This committee, ably chaired by Daisy Gallagher, was established to explore the solutions we could offer to our legislators to contain the ever-rising cost of malpractice and health insurance. The committee has met with various segments of the health care community. Daisy and her committee get kudos for a job well done.

Last but not least, the Building Committee, chaired by Karen Goumakos, was formed to look at our current building and whether we can afford or need to relocate to another building. The consensus was that we cannot afford to move at this time but that, finances



permitting, a sinking fund should be established so that we can consider a move sometime in the future. In the short term, they have made several recommendations on how to re-do the lobby and give it a more professional appearance. Karen and her committee are to be thanked for all their time and effort in this endeavor.

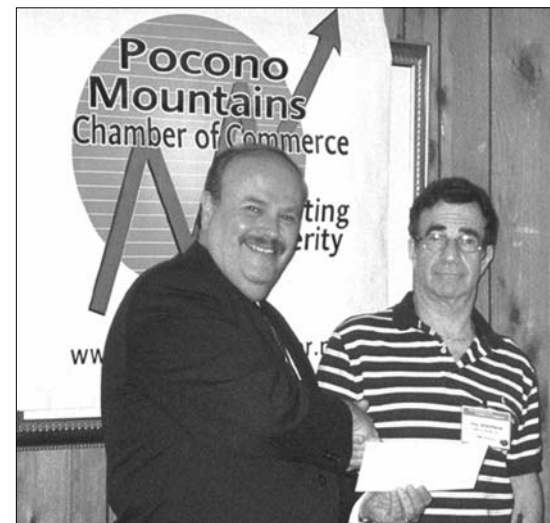

Balloon Festival Huge Success

Balloon Hilda, Uncle Sam and the Liberty Bell floated over crowded midways filled with the smiling faces of the visitors as well as food and craft vendors as the event was blessed with near perfect fall weather, peak fall foliage, and record crowds.

The Pixie Chicks played to a full house at the Shawnee Concert Stage on Friday evening and the light rain that fell didn't diminish the awe of the annual balloon glow or the excitement of the evening's finale fireworks show presented by the Poconos' own Castiglio Fireworks Company.

Saturday presented the festival with a classic fall day, which started with perfectly calm conditions for balloon launches and every balloon launched with a full load of passengers. Then under sunny skies the Jolly Reinlanders serenaded the food court and Banko Beverage saw record beer sales. The crowds built throughout the day culminating with the headlining CAST of Beatlemania who took the crowd through a two-hour tour of the historic Beatle years. Rock, soul and county music spilled onto the midway from the Shawnee Concert Stage and strolling musicians, clowns, and magicians wandered the crowd. The weather held through the afternoon and allowed a second full balloon launch.

Sunday dawned on a second near perfect fall day and a second day of record crowds, family fun and a second day of balloon launches.
