


Chamber Hosts 15th Annual Report to Business





Health Care Task Force To Study Issues Affecting PA

USA Today has recently reported that the number one business issue (which prior to 1984 was rising taxes) is now the cost of health care. Last year, your Chamber assembled a task force made up of medical professionals, leaders in the business community, legislators, attorneys, insurance companies, and other chambers (including our State Chamber of Commerce and the United States Chamber of Commerce). In a 2003 Summary Report Paper, this Health Task Force offers our findings and possible solutions, as well as indicating the views of the Pennsylvania and U.S. Chambers, Governor Rendell, and President Bush. Some issues raised in this report include, for example, that disincentives lawsuits should be explored to ensure that appropriate lawsuits receive appropriate payments; that multiple factors have contributed to increased premium rates, as cited in government report GAO-01-702; and that the rising health care costs will have a negative impact on local employers trying to remain competitive, as well as on their recruitment efforts and retainment. The task force will address other questions in the future, such as whether all county residents can be placed in a single self-insured group to result in better health care at more affordable insurance rates; how to educate the public in Pennsylvania on these matters; how tort reform will affect health care; and what are the leading drivers of increased health care costs. This report will be available on our Web site, www.poconochamber.net. We will continue to take a leadership role by studying the state of health care and communicating our findings and recommendations to our membership.


