THE CHAMBER'S YEAR IN REVIEW

As the year 2006 comes to an end, it is a great opportunity for the Chamber to use the IMPACT's cover page to report to you- the members- with a summary of our accomplishments for 2006.

Robert P. Phillips, IOM, President/CEO has been appointed to the Pennsylvania Industrial Development Authority Board, known as the PIDA Board, by Senator Robert Mellow as the Senator's representative. The Chamber hosted a breakfast with James Creedon, the Secretary of Department of General Services.

Chamber's Business Resource Center and its Small Business Development Committee have achieved the following milestones:

- Nine seminars including "Doing Business with the Commonwealth of PA," HUBZONE (Doing Business with the Federal Government), Business Start up, Marketing, Financing, and Legal Issues and Accounting. 275 individuals attended these workshops.
- 400 individuals received business consultations through oneon-one or group counseling.
- 29 new businesses assisted to start and 36 existing businesses received assistance to take their entities to the next level.
- 335 new jobs were created.

Business Card Exchanges and Monthly Breakfasts brought a significant amount of networking among the business community within the region. More than 3,000 individuals attended these two events.

Government Affairs Committee (GAC) has hosted all six senatorial and House of Representative debates for the mid-term state election. All debates were televised live.

Membership has reached 1,900 members in 2006, a new height in the Chamber's history.

HR Committee held a HR Conference on September 19 at Shawnee Inn & Golf Resort with more than 100 people in attendance.

TV Programming- Thanks to George Roberts Production, "Pocono Mountains Business Magazine" the Chamber's TV Show has reached 91,000 viewers. 60% of the viewers are Presidents, CEOs, and Executive professionals. 63% of the viewers are between 35 to 54 years old and 35% of the viewers watch the show several times a month. The Bizzy Awards was created and conducted for the first time to highlight the region's businesses for excellence in ten different categories.

Radio Programming-The Chamber aired a weekly radio show to educate and inform the community as well as to introduce member businesses to the region.

EXPO 2006- Representatives of 187 businesses and organizations showcased their products and services to more than 5,000 attendees in a two day event that was held at East Stroudsburg University of Pennsylvania.

Women in Business luncheons continued to offer powerful and insightful business seminars with the tools to assist businesses to succeed.

Ouality of Life Committee held their 27th Annual Golf Tournament at Skytop Lodge with 120 golfers in attendance. The committee is also sponsoring a Children's Holiday Party event at the Salvation Army.

Breakfast with the Secretary of the Department of General Services

The Pocono Mountains Chamber of Commerce held a breakfast on Tuesday, November 14, 2006 at the Chateau Resort & Conference Center with Mr. James Creedon, Secretary of the Department of General Services as the guest speaker. Mr. Creedon discussed how his department cut operational costs.

He reported on several of the savings such as: \$180 million in procurement through their Strategic Sourcing Program, 8% reduction in energy consumption, eliminated in excess of 1,000 automobiles from their fleet (they now turn in cars at 100,000 miles, not 60,000), with a savings of \$32 million and reduced out change order rate from 20%-5%, with a savings of \$40 million.
