As we begin a new year, the Pocono Mountains Chamber of Commerce Government Affairs Committee will be focusing on key legislative priorities for the membership. Three of these legislative priorities are rapidly raising health-care costs, overly burdensome business tax structure, and school property tax reform.

The Chamber realizes that health care costs continue to rise at unprecedented levels. Business owners need to be able to offer affordable health care coverage for their employees and their families. There are other issues that the Chamber will undertake such as environmental laws, infrastructure systems, economic development programs, and workforce development. Our commitment is to work with our elected officials to solve the issues that affect our members and our community.
