Recently, the Chamber attended a seminar on Immigration Law & Best Practices and we would like to share with you, information that was released by the **U.S. Immigration & Customs Enforcement.**

Each year, the Social Security Administration (SSA) informs thousands of employers via a "no-match" letter that certain employees' names and corresponding Social Security numbers provided on Forms W-2 do not match SSA's records. Out of approximately 250 million wage reports the SSA receives each year, as many as four percent belong to employees whose names and corresponding Social Security numbers do not match SSA's records.

Through regulation, the Department of Homeland Security (DHS) is reiterating that employers remain accountable for the workers they hire and clarifying the steps employers should take to resolve mismatches identified in letters issued by SSA. The DHS regulations provide guidance that will help employers comply with legal hiring requirements by outlining specific steps they should take under immigration law when they are notified that employees' names or corresponding Social Security numbers as provided on Forms W-2 do not match SSA records.

SSA is not changing its procedures for issuing employer no-match letters, and SSA guidance on how to correct Social Security records will remain unchanged. However, no-match letters issued by the SSA for Tax Year 2006 will be accompanied by a letter from U.S. Immigration and Customs Enforcement (ICD) informing employers on how to respond to the employer no-match letter in a manner consistent with obligations under U.S. immigration laws.

There are many reasons for a mismatch between employer and SSA records, including transcription errors and name changes due to marriage that are not reported to SSA. Employers should not assume that the mismatch is the result of any wrongdoing on the part of the employee. Moreover, an employer who takes action against an employee based on nothing more substantial than a mismatch letter may violate the law.

The DHS regulation and the ICE letter describe with specificity what steps employers should take upon receipt of a no-match letter: 1) verifying within 30 days that the mismatch was not the result of a record-keeping error on the employer's part; 2) requesting that the employee confirm the accuracy of employment records; 3) asking the employee to resolve the issue with SSA; 4) if these steps lead to resolution of the problem, follow instructions on the no-match letter itself to correct information with SSA. and retain a record of the verification with SSA: and 5) where the information could not be corrected, complete a new I-9 form without using the questionable Social Security number and instead using documentation presented by the employee that conforms with the I-9 document identity requirements and includes a photograph and other biographic data. Employers unable to confirm employment through these procedures risk liability for violating the law by knowingly continuing to employ unauthorized persons.

Their big news is that they have been acquired by First Keystone National Bank of Berwick on May 11, 2007. First Keystone National Bank, formerly First National Bank of Berwick, has been in business for more than 140 years. Their tagline, "Yesterday's Traditions, Tomorrow's Vision" accurately describes what both banks strive to do for their customers. The Special Program was Equi-librium, Inc. Pat Sayler talked about Equi-librium and how it is therapy focused around horses. In 2000, Easter Seals had to drop the program because of lack of funding. In 2001, Equi-librium opened its own facility in Sciota. They went from being able to help 56 kids per year to 120 per week. In the future they hope to expand to a larger facility. They now own land in Northampton County, but have to raise the money to build there before relocating. HR Corner

Does Unused Sick Time Hold Off the "Cobra" Bite?

Question: We have a 24-year employee who has accrued many sick days and still has some left even though she has been unable to work for three months due to illness. Our benefits person says we can't stop paying for her group health insurance coverage and put her on COBRA until she exhausts her paid sick time. Is this correct?

Answer: No. The mere availability of paid sick time does not forestall an employer's ability to stop paying for group health insurance coverage for an employee unable to work due to injury or illness. For employers with 20 or more employees, COBRA applies whenever a qualifying event such as a reduction in hours or termination results in loss of such coverage.

Except for the Family & Medical Leave Act which obligates larger employers to continue coverage for eligible employees for up to 12 weeks, it is the terms of an employer's collective bargaining agreement, individual employment contract, policy, or practice that determines when an employee's inability to work results in loss of coverage.

For example, a non-FMLA covered employer (with fewer than 50 employees) may adopt a policy of continuing to pay for an absent employee's coverage for only 2 months. Thereafter, assuming the employer is covered by COBRA, the employee may be required to pay for COBRA continuation coverage while on leave even if she still has accrued but unused paid time off.

Ideally, this should be handled consistently as to all employees on this type of leave for this duration pursuant to some established agreement, policy or practice.

From the President



Below is some additional information about the front cover story from this month's Impact regarding immigration. This article was published by the U.S. Department of Homeland Security.

About E-VERIFY

- E-Verify is a free and simple to use Web-based system that electronically verifies the employment eligibility of newly-hired employees. For more information on E-Verify visit www.dhs.gov/E-Verify.
- E-Verify is a partnership between the Department of Homeland Security (DHS) and the Social Security Administration. U.S. Citizenship and Immigration Services (USCIS) oversee the program.
- E-Verify is a re-branding of its predecessor, the Basic Pilot/Employment Eligibility Verification Program, which has been in existence since 1997. The Basic Pilot is being re-branded to highlight key enhancements in the program including a new photo screening tool that helps employers to detect forged or faked immigration documents.
- E-Verify works by allowing participating employers to electronically compare employee information taken from the Form I-9 (the paper-based employee eligibility verification form used for all new hires) against more than 425 million records in the Social Security Administration's (SSA) database and more than 60 million records in DHS immigration databases. Results are returned within seconds.
- E-Verify is the only official U.S. Government source that provides employers in the United States with real-time data that takes the subjectivity out of verifying employment eligibility.
- The primary goals of the EEV program are to protect jobs, not lose jobs, for authorized U.S. workers and to ensure a legal workforce in the United States.
- Currently, more than 19,000 employers are enrolled in E-Verify and 1000 new employers are signing up each month. The system is currently capable of handling up to 25 million inquiries a year.
- Through E-Verify, participating employers have successfully matched 92 percent of new hires to DHS and SSA database information. Of the remaining 8 percent that were not matched, less than one percent of those employees contested the result.

This is very valuable information and I wanted to share it with our members.
