The Pocono Raceway Solar Project has been recognized as the winner of the 2011 Excellence in Renewable Energy Awards, Readers Choice Award. Of the hundreds of nominees, The Pocono Raceway Solar Project was one of four finalists selected by the Renewable Energy World Network of Editors. Pocono Raceway's Solar Project was recognized for its achievements in developing the world's largest solar-powered sports facility. The award was announced at the Renewable Energy World Conference & Expo in Tampa, Florida on March 8, 2011.

The Renewable Energy World Conference & Expo has been a leading event in the renewable industry for eight years. Jim Callihan, President of RenewableEnergyWorld.com, said of the winner, "Pocono Raceway exemplifies the kind of company that will lead our economy to the next generation of energy excellence and make our planet a safer, cleaner place for the future."

The Pocono Raceway Solar Project, developed by enXco and Evolution Energies, and owned by Pocono Raceway is located along Long Pond Road adjacent to the storied Raceway. The installation consists of nearly 40,000 American made photovoltaic modules that will produce more than 72 million kilowatt hours (kWh) of energy over the next 20 years. The environmental attributes associated with the system will offset more than 3,100 Metric Tons of carbon dioxide annually and will generate enough power to provide the electricity needs for over 1,000 homes beyond the power needs of Pocono Raceway.

"This is an important milestone for Pocono Raceway and our sport," said Brandon Igdalsky, President of Pocono Raceway. "Pocono Raceway strongly believes in the NAS-CAR industry's commitment to operate in a more environmentally responsible way and is proud to be the first race track to power our sport with clean, renewable sunlight. This solar power system, built with timber, steel and solar panels made in the U.S., satisfies all our Raceway's energy needs, while helping to power local homes. This project demonstrates real sustainability and proves that any business that truly wants to go green can do it."

Pocono Alliance Understanding Poverty Seminar

Due to the current economic decline, it is clear that individuals and families are truly struggling and that resources for assistance are shrinking throughout the state. Now, more than ever, it is essential that human service agencies work together to bring about change in their community.

On May 12, 2011, Pocono Alliance will host the "Understanding Poverty" seminar from 8:30 am to 12:30 pm. at East Stroudsburg University. Dr. Judith Bell of Volunteers of America of Northern Louisiana will offer powerful and thought-provoking insights on the issues of poverty to promote awareness, understanding and strategies to help move people from poverty.

If you do not live in poverty, you may be unaware of the "hidden rules" that govern many aspects of life for the poor. People in poverty are often in survival mode, where the future holds no promise, and support systems taken for granted in middle class and wealth are nonexistent. If your business, agency, or organization works with people from poverty, only a deeper understanding of their challenges and strengths will help you partner with them to create opportunities for success.

The seminar, based on relevant materials from Ruby Payne's book, "*Bridges Out of Poverty*", a powerful tool designed for social, health and legal services professionals, has implications for everyone including education, social services, healthcare, law enforcement, corrections, business, faith based and government. For eight straight years, Shawnee has worked in partnership with the <u>Great American Clean-Up of PA</u>. Community members, resort guests, and Shawnee employees have shared the benefit of knowing their efforts have positively impacted the environment along River Road. Registration is open to the resort guests and the local community. The first 100 volunteers to pre-register are eligible to receive a t-shirt commemorating the event. Directly following the clean-up, an appreciation luncheon will be offered to volunteers at The Gem and KeystoneTM Brewpub.

Registration is from 8:00 am - 8:30 am at the Shawnee Inn and Golf Resort – follow signs to the River Sanctuary (pavilion). At registration, volunteers will be given garbage bags, gloves, a safety vest, and safety instructions. Children under the age of 18 must be accompanied by an adult.

Mónica Startari, event founder states, "It is rewarding to see more people come out to volunteer year after year. We started out with 15 volunteers eight years ago and now we get well over 100. This is great since we need a lot of volunteers to cover 8 miles of River Road..." (from Welcome Center to NPS Headquarters). Mónica also shared with us that this year will the second year in a row that recycling will also be part of the clean-up. All found glass, plastic, and aluminum will be placed on specific color bag to be easily identified by the Resort's grounds crew during the litter collection. In 2009, Monica received a national recognition with an award from the Delaware Water Gap National Recreation Area, for her efforts in conserving and protecting the natural and cultural resources within the park through this clean-up.
