From the Chairman of the Board Reflection and Thanks

The holiday season is a time to give thanks, reflect on the past year and look ahead. As 2008 enters its final weeks, I hope all

our members find multiple reasons for thanks, including good health and many friendships. As Greater Pocono Chamber of Commerce members, there is much to reflect on. Historic economic and political events of the past seventy five days will shape our country for years to come. At the national level, it has become increasingly difficult to keep up with the number of industries (not just individual companies) seeking some form of financial assistance from the United States Treasury. The term



"bailout", once limited to the isolated treasury loan to the Chrysler Corporation in 1980, now describes countless proposals to assist financial services, banking, automotive and (in Pennsylvania) even a chain of retail department stores.

Theories abound as to whether it is a proper governmental function to take a financial stake in a financially stressed industry. The most common argument in favor of public intervention is the preservation of jobs. A common argument against loaning money to a struggling enterprise is there is no public interest in loaning fresh dollars to an enterprise with a failing business model. On a humorous note this week's "Prairie Home Companion" radio program (I'm a sometimes listener) included a sketch between a small business manufacturer and a banker. The business owner made his case for a new line of credit, despite poor sales, with a blind optimism about the future. The banker looked at the numbers, shook her head and said "What product is it you manufacture?" "Telephone booths" replied the businessman...

The point is, uncertain markets for business capital and customer demand may be with us for some time. A time for thanks, reflection and looking ahead permits (if not requires) each of us to examine the very business model upon which our business organization is based. I think most of us can agree the telephone booth manufacturer needs to get another product line, fast! The more challenging task lies with each of us to review our delivery of goods and services to a target population. What is the most effective advertising? How can I recruit employees with the necessary skill set? How can I keep current with technology necessary to meet client or customer expectations?

Viewed in this context, the present economy presents both a challenge and an opportunity. Creative, fresh ideas and critical yet constructive thinking should be cultivated among owners, managers and staff. This applies to businesses of all size, professional practices and not for profit organizations, as well. To his end your Chamber Board will conduct a Board workshop in January to assess goals, priorities and service to membership. More to follow in 2009. For now here's hoping you seek the time to give thanks, reflect and look forward to a progressive new year.

The EFCA: Big Labor's Big Ticket By: Brian A. Caufield

While it did not receive the same media attention as the ongoing financial crisis, the misleadingly named Employee Free Choice Act (EFCA) will be a hot-button issue following the recent presidential election, and threatens to have a significant impact on this country's economic well-being. As proposed, EFCA will cause the most drastic overhaul of private sector labor relations since the passage of the National Labor Relations Act (NLRA) in 1935. Ironically, if passed into law, EFCA will severely restrict employees' free choice when it comes to deciding whether they wish to be represented by a union.

EFCA passed by a wide margin in the House of Representatives last year but was derailed in the Senate. President Bush stated that he would veto the bill. Given that the Democrats have solidified their control of the Senate and President-elect Barack Obama supports the bill, it is a virtual certainty that EFCA will be reintroduced in 2009.

EFCA will significantly alter the NLRA in at least three ways. First, EFCA allows for "card-check" certification of unions, meaning that once a union gets a majority of employees to sign authorization cards, it will become their collective bargaining representative. Under current labor law, an employer has the option of voluntarily recognizing a union based on receiving a majority of signed authorization cards, but also has the right to refuse to recognize a union on that basis and instead, insist on a National Labor Relations Board (NLRB) secret-ballot election to determine if employees wish to be union represented.

The overwhelming majority of employers require unions to go through the NLRB election process. Signed union authorization cards from employees are frequently the result of peer or union pressure and do not accurately reflect employee sentiment, which is best expressed in a secret-ballot election. Also, under EFCA's card-check certification procedures, unless an employer has advance notice - which rarely happens - that cards are being circulated among the work force, it will have no opportunity to communicate its views regarding why a union is not in the employees' best interests.

The second major change under EFCA severely impacts the employer's ability to negotiate a fair collective bargaining agreement. Under current law, the parties are required to bargain in good faith with regard to wages, hours and other terms and conditions of employment. An employer cannot be "forced" to agree to any union proposal. Once an agreement is reached, it is subject to a ratification vote by the employees. Under EFCA, if a contract is not reached within 90 days, either side can request mediation. If, after 30 days of mediation, there is still no contract, an arbitrator is appointed to impose the terms of a binding two-year contract. The arbitrator is not bound by the prior negotiations, and the employees do not get to ratify the contract. The effect will very likely be that an employer may end up agreeing to most of the union's demands rather than risk having an arbitrator (who knows nothing about its business) decide the contract.

The third major change EFCA makes to existing law is the punitive set of penalties imposed on employers who are found to have violated the NLRA during a union organizing campaign or during contract negotiations. In contrast to the NLRA which provides for remedial penalties, under EFCA if an employer discharges or discriminates against an employee during a union organizing drive or first contract negotiations because that employee engaged in union activities, the employer is required to pay the employee triple back pay. EFCA also provides for fines of up to \$20,000 per violation against employers who willfully or repeatedly commit unfair labor practices during a union organizing drive or first contract negotiations. Finally, EFCA requires the NLRB to seek an injunction against employers when there is reasonable cause to believe they have interfered with a union organizing drive or first contract negotiations. These penalties are to be imposed only against employers.

Clearly, if passed, EFCA will reinvigorate the labor movement. The Service Employees International Union estimates that the ease of unionizing under EFCA would allow it to organize one-million workers a year, as opposed to the 100,000 workers it currently organizes annually.

Nonunion employers and employers where unions represent only a segment of the work force are strongly advised to take certain precautions to prepare themselves in the event EFCA becomes law. Some recommendations for employers include:

- Use this time to review wage and benefit programs and make sure that no item lags far behind the norm in the area
- Watch for signs of union organizing and specifically, the soliciting of cards
- Formulate and prepare to communicate a campaign strategy (i.e. negatives of being in a union and positives of being union free) before the union gets a majority of employees to sign cards

Businesses submit their application (ONLY 1 Page) available at www.newpa.com. They type Educational Improvement Tax Credit Program in the search bar, and download the PKTC Business Guidelines (see Appendix i). The application is within. The business will receive written notification of approval from the Pennsylvania Department of Community and Economic Development (DCED). They would then send their contribution within 60 days of approval to PHCA, as we are a Pre-K scholarship organization. PHCA will send written acknowledgement within 30 days and will forward a copy of acknowledgement to DCED within 90 days. Businesses then file their tax return as usual and claim tax credit for contribution!

Another easy way for businesses to give back to the community (and receive a lot of advertising) is to donate to the School Readiness Calendar fund. This calendar, sent to over 5,000 families, details different learning topics with suggested daily activities. The calendar includes a list of children's books that will not only keep the attention of a 4 year old, but stimulate learning. The School Readiness Calendar ends with a "List of Import Skills," and a checklist that allows parents to monitor and track their children's physical, social, emotional and cognitive development. The calendar is based on the Pre-K Early Learning Standards from the Pennsylvania Department of Education and Public Welfare. By using the calendar, as a guide, parents become "partners" supplementing and supporting the work of their children. There are two ways you can contribute to the creation of the calendar:

Sponsorship at the \$250 level will promote your business name on the back cover of the calendar.
