Greater Pocono Chamber of Commerce Celebrates 100 Years!

On March 3, 1910, the third Board of Trade was organized. Robert Brown, Sr. was elected temporary chairman and Dr. W.C. Snover, temporary secretary.

Mr.Brown stated that "the object of the Club was to cultivate the social side, as well as to look after the business welfare of our town. The idea being to rent and furnish suitable quarters, where the members can meet for recreation or business."

The Stroudsburg Industrial Club received its charter on June 25, 1910. Even then, it held the industrial and mercantile interests of the region at heart. As noted in its charter, the corporation was formed "for the purpose of establishing a body with authority to deal with matters of interest to the general public of the Borough of Stroudsburg by promoting the prosperity of the mercantile and the manufacturing enterprises of the community."

The name of the Stroudsburg Industrial Club was later changed to The Stroudsburg Chamber of Commerce. The officers of the Chamber were: Stewart Flagler, President. Mr. Flagler was the owner of the Phoenix Drug Store located at 611 Main Street. (cont'd on page 2)

The 14kt Outlet is currently at that location. P.R. Johnson, Vice-President. He was also the President of the Security Trust Company located at 713 Main Street. This is currently home to KNBT. L.E. Lord, Recording Secretary, was a watchmaker at 560 Main Street. Richmond & Associates currently occupies that location. F.L. Stackhouse, Treasurer, was a bookkeeper at 1125 Main Street. This location is a private residence.

On May 12, 1911, the Stroudsburg Industrial Club, now the Stroudsburg Chamber of Commerce, started a movement headed by Harry E. Sweeny to build a Convention Hall. The Club appointed five individuals to form a committee whose purpose was to lay plans for and promote the movement. The members of this committee were R.B. Keller, A.C. Sweazy, H.E. Sweeny, W.W. L'Hommedieu and L.J. Brown.

After spending a year planning, estimating, and discussing ways and means, it was decided a Theater would be built with local capital and stock sold by the committee.

The stock holders formed a Corporation called the Huston Realty Company and purchased the Huston property at the corner of N. 6th Street and Quaker Alley. They engaged architect Harry Weaver to draw up plans and proceed with the construction of the Theatre so that Stroudsburg would have a beautiful, fully-equipped Theatre with a large stage. The second floor contained four large rooms, a kitchen, cloak room and wash room. This floor was specially designed for the Chamber of Commerce and was occupied by them for many years.

During its 100 year history, the Chamber of Commerce has demonstrated its commitment to providing an optimum business environment for its members. - Monroe County Chamber of Commerce, 1932
- Pocono Mountains Chamber of Commerce, April 2 1948
- Greater Pocono Chamber of Commerce, September 25, 2007

Ten scholarship applicants were graded on their academic record, extracurricular involvement, work and community service, and their personal interview. Of the 10 applicants, Frank Argentieri, Michael DeBrincat, Jefferson Ramirez and Stephen Wachowski received the highest scores and were each awarded one this year's four scholarships.

In years past, the PFCCA Golf Committee awarded two scholarships to deserving seniors however this year, Pocono Farms CC lost two very active residents, Mr. Steve Butler and Mr. Bob Stephen whose generous family members set up scholarships in their loved ones memory.

All contests are designed, run and judged by industry using industry standards.

Top student winners received gold, silver and bronze medallions. Many also received prizes such as tools of their trade and/or scholarships to further their careers and education. The SkillsUSA Championships is for high school and college-level students who are members of SkillsUSA. In addition, for the fourth year, high scorers in the contests received Skill Point Certificates. The Skill Point Certificate was awarded in 90 occupational and leadership areas to students who achieved a high score defined by industry. The SkillsUSA Championships have been a premier event since 1967. The Skill Point Certificates were introduced three years ago as a component of the SkillsUSA Work Force Ready System.

- * Charles B Livezey, from Effort and a student at Monroe Career and Technical Institute (Bartonsville), was awarded a Skill Point Certificate in Residential Wiring.
- * Team F (consisting of Cody Tempelton, Barry Cusano III, Michael Jeans), from Career Institute of Tech (Easton), was awarded a Skill Point Certificate in Community Service.
- * Team D (consisting of Hasim Z Paputchi, Tyler M Bartron, Alex A D'Antonio, Fabio A Peralta), from Monroe Career and Technical Institute (Bartonsville), was awarded a Skill Point Certificate in Entrepreneurship.

"Over 5,600 students from every state in the nation came to compete in the SkillsUSA Championships this week," said SkillsUSA executive director Tim Lawrence. "This is the SkillsUSA partnership at its best. Students, instructors and industries are working together to ensure America has a skilled work force and every student excels. These students prove that career and technical education expands opportunities."

According to Lawrence, recent survey data says that 75 percent of these students will go on to higher education. Included in that number are 40 percent who will be attending college and working at the same time. Of those graduating from school, 76 percent plan to work in the field for which they've trained.

"They're the employees industry wants to hire and promote," Lawrence said.

Industry support of the SkillsUSA Championships is valued at over \$35 million in donated time, equipment, cash and material. All contests are run and judged by industry experts using industry standards for employment. Contests assess hands-on, employability and academic skills. Over 1,600 industry judges and technical committee members participated this year.

The SkillsUSA Work Force Ready System was developed as an extension of the SkillsUSA mission and supported by a grant from the W.K. Kellogg Foundation. The System recognizes students for excellence in occupational training; it assesses and documents the entry-level technical proficiency and cumulative experiences of candidates.
