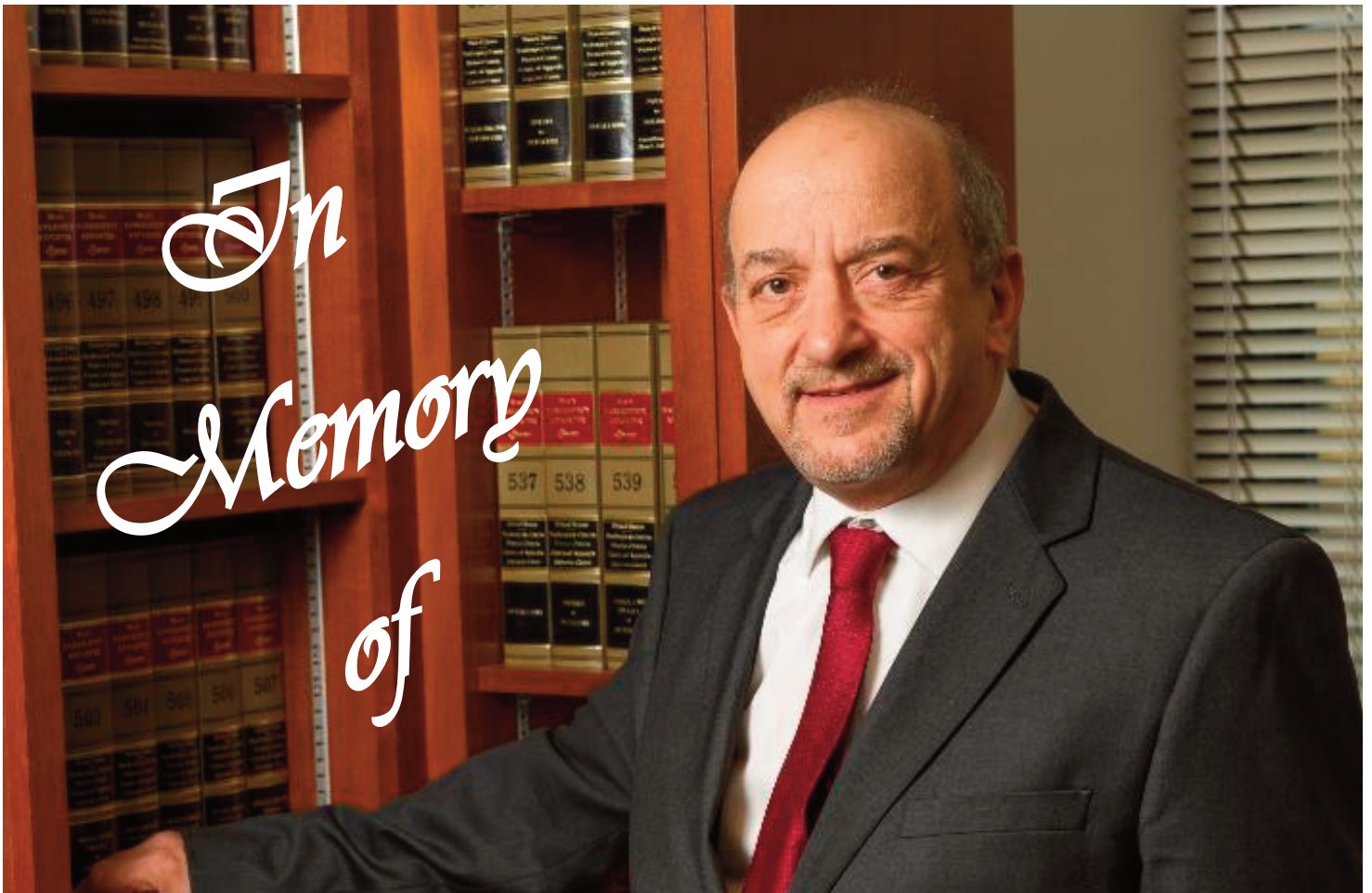

# The 21st Annual Middle District Bankruptcy Bar Association Conference

will be held on June 13 and 14, 2019 at the Hollywood Casino in Grantville, PA. As in past years, the conference will offer continuing legal education credits for bankruptcy practitioners. In 2018, approximately 125 judges, attorneys, paralegals, legal assistants and vendors attended the event. The Association welcomes the Honorable U. S. Bankruptcy Chief Judge Robert N. Opel, and the Honorable U. S. Bankruptcy Judge Henry Van Eck from the Middle District of Pennsylvania.

The conference's first CLE course will be a presentation by Judge John Thomas's career law clerk, Rich Rogers, who will review Judge Thomas's most notable cases. Other courses will include Pre-filing Preparation; Roundtable on Bankruptcy Practice; Mortgage Company Fees and Disputes and numerous other concurrent sessions addressing evolving areas of bankruptcy law. In addition to the standard "Attorney Track" the schedule again has a separate track for paralegals and legal assistants.

We are also excited to welcome our Keynote Speaker, Pennsylvania Auditor General Eugene DePasquale. The Auditor General's presentation, which will occur during the included buffet luncheon, is accredited for 1 substantive CLE credit.

As in years past, the day will again offer up to 6.0 credit hours of CLE – a maximum of 6.0 Substantive Credits and a maximum of 1 Ethics Credit, depending on the classes attended. However, as one of those credits will now be earned during the luncheon, the day will end earlier.
