**Ordinance 2012-102 Vacating a portion of Appenzell Terrace Road:**

Land that is adjacent to land now owned by Ronald P. McMaster that was formerly intended for use as a cul-de-sac; however, it was never used for that purpose – the property is approximately 0.106 acres more or less.

Donald Kresge Sr. made a motion to approve Ordinance 2012-102 Vacating a portion of Appenzell Terrace Road. Motion seconded by David Thomas. All voted aye. Motion carried.

**David McNeese Sr.:**

Mr. McNeese is a Jackson Twp. resident who resides in Chatham Hills Development, with his property split between Jackson & Chestnuthill Townships. Mr. McNeese started by thanking Jackie Elliott and the Roadcrew for all their help in the past regarding his concerns in his development. Mr. McNeese is asking that Jackson Township when brooming the roads, and also tarring & chipping, if it would be possible to maintain the road continuously throughout Chatham Hills Development instead of stopping in front of the properties that are in Chestnuthill Township. Jackson Township maintains the roads for snow removal.

Supervisor Rader advised he will speak to Chestnuthill Township Supervisors and ask if they could enter into a Township Mutual Aid Agreement, where Jackson would tar & chip Chestnuthill Township portion in exchange for Chestnuthill Township doing some type of road maintenance in Jackson Township.

**Waiver Request – Andrade:**

Cesar Andrade has requested a waiver to install the required holding tank and bollards between the inner and outer stream buffers. David Thomas made a motion to grant the waiver request. Motion seconded by Donald Kresge Sr. All voted aye. Motion carried.

**Pension Chief Administrative Officer:**

The prior Pension Chief Administrative Officer was named as the Township Office Manager, and needs to be changed per the Auditor. Donald Kresge made a motion to name the Pension Chief Administrative Officer as Township Secretary. Motion seconded by David Thomas. All voted aye. Motion carried.
