JACKSON TOWNSHIP SUPERVISORS GENERAL BUSINESS MEETING MINUTES April 12, 2018

The Jackson Township Board of Supervisors General Business Meeting was called to order by Chairman Donald C. Kresge Sr. at 7:00 PM.

Members present: Donald C. Kresge, Sr., Lester Wolcott and Solicitor Todd Weitzmann.

Plot Plans:

Land Development Amendment Waiver Request – Cameltop Mountain Lodge Improvements:

Jackson Township Planning Commission has recommended granting the waivers. The Plan itself is still under review by the Planning Commission. A letter dated Dec. 18, 2017 from RKR Hess, Nathan Oiler, advises CBH20 LP has submitted an application for improvements to the existing Cameltop Mountain Lodge. This application is an amendment to an existing Land Development. The existing parking lot was approved in 1978 as a gravel parking lot and has been maintained in this condition. A new 14 parking space lot was created. A waiver of the pavement requirement for parking areas in the current SALDO is requested based on adequacy of the stone surface to provide an adequate surface for the low seasonal usage anticipated for the new parking lot as permitted in waiver in 612.10.C

The applicant is requesting that the requirements to pave the parking lot in section 612.10B be waived.

Also, due to the limited scope of the Land Development, the applicant is requesting a waiver from the following portions of the Subdivision and Land Development Ordinance (SALDO):

Section 406.2 A waiver is requested that a Site Context Map not be required.

Section 406.3 A waiver is requested that an Existing Resources and Site Analysis not be required.

The applicant is requesting that these requirements be waived as they believe the mapping included in the application provides adequate information for review given the limited scope of this project.

Lester Wolcott made a motion to approve the waiver requests as stated. Motion seconded by Donald C. Kresge Sr. Both voted aye. Motion carried.

Lester Wolcott made a motion to authorize a letter be sent to DEP – Attn: Todd Stires, Sewage Planning Specialist indicating that Jackson Township acknowledges that the Cameltop Lodge is located in the Camelback WWTP service area. Motion seconded by Donald Kresge Sr. Both voted aye. Motion carried.

High Inc. to supply, deliver and install (7) 30 Foot, Class 4, CCA treated wood poles for \$3100. Motion seconded by Donald Kresge Sr. Both voted aye. Motion carried.

Lester Wolcott made a motion to approve the Proposal from Schuylkill Valley Sport for 3 nets to cover the 125' space for \$2980. 3 separate nets will make it easier to keep the net taut, easier to install and take down. Motion seconded by Donald Kresge Sr. Both voted aye. Motion carried.

Marick Lane Inspections:

Hanover Engineering has reviewed the available files and performed a field inspection of Marick Lane to provide a recommendation of required improvement and maintenance items which would be required to formally dedicate the road to Jackson Township. The estimated construction cost is \$21,360.00. This information has been given to the residents who came before the Board of Supervisors regarding road dedication.

Singer Avenue – road vacate:

Singer Avenue is being surveyed and a legal description will be written. At this time we are waiting for the survey to be completed and the report from the engineer.
