Ordinance 2018-100 Short Term Rental:

Solicitor Todd Weitzmann explained the township has been discussing this issue for a number of years now. Zoning Officer Michelle Arner gave an overview of the proposed ordinance. This ordinance will apply to all properties within the township, to allow home owners the ability to rent their homes short term – meaning less than 30 days. It is a short term/vacation rental used as a source of income. The fees for this will be an Initial Fee \$300, with an Annual Renewal Fee \$100. Solicitor Weitzmann explained the Initial Fee of \$300. will hopefully cover the cost of an inspection, administrative fees, permitting process etc. A group of individuals within the township, consisting of planning commission members, zoning hearing board members and residents, along with Zoning Officer Michelle Arner met to discuss the criteria needed for the ordinance.

After some discussion with local realtors, and township residents – Donald Kresge Sr. made a motion to adopt Ordinance 2018-100 Short Term Rental. Motion seconded by Mark Major. All voted aye Motion carried.

Resolution 2018-02 Fee Schedule:

The fee schedule will include fees for Ordinance 2018-100 Short Term Rental as well as amendments to the existing fee schedule.

Lester Wolcott made a motion to adopt Resolution 2018-02 Fee Schedule. Motion seconded by Mark Major. All voted aye. Motion carried.

Running Valley Road – Fox Chase Road resident:

A Speed limit sign of 25 mph is posted; however, the vehicles are flying and going much more than 25 mph, it's a dangerous area to pull out onto Running Valley Road. She questioned whether or not the township could install a stop sign in the middle of Running Valley Road hill at the intersection, or perhaps put in speed bumps.

Roadmaster Donnie Kresge Jr. advised the township can't have people stopping in the middle of the hill, especially during winter time. Speed bumps cannot be installed because of the motorcyclists, as well as winter road maintenance and snow plowing. It was suggested she call Fernridge State Police to see if they can watch this area, or put in a device to measure the speed being traveled on this road.
