Supervisor Position Vacancy:

David Shields:

David Shields Jr. and David Shields Sr. addressed the Board of Supervisors concerning a recent violation notice David Shields Jr. recently received. Violation notice addresses the use of mobile home/camper on property with no permit and septic. David Shields Jr. stated this is incorrect. Solicitor Todd Weitzmann explained that this is a Zoning Board matter. The matter would have to be reviewed at a Zoning Board Hearing, if he wishes to appeal. The appeal process was explained as well. David Shields Jr. has 30 days from the date of the notice of the violation to appeal. In the event he fails to appeal within the 30 days, he waives his right to appeal. David Shields Jr. and David Shields Sr. understood.

Guard Rail/ Parking Lot Bumpers- HJP Regional Park:

Quotes for a guardrail and parking lot bumpers were reviewed and discussed. Mark Major stated the metal guardrail would not "blend well "with the landscape of the Park. The parking lot bumpers may not provide enough protection to prevent vehicles from going down the steep embankment. Mark Major made a motion to table the decision pending further review. Donald C.
