Plot Plans:

Ray Property Demolition Update:

Todd Weitzmann advised proposals and advertisements are still in process. More information will be available for the General Business Meeting in August. A plan for the Jackson Township Volunteer Fire Company to use the site demolition for a burning drill is being considered. Safety concerns involving the structure and materials will need to be addressed.

New Business:

Gardner Rd./ Reeders Run Rd Stone Bridge Repair Bid:

Bid received by Bob & Mike Wallingford Mason Contractors in the amount of \$2280.00 to repair the stone bridge on Gardner Rd/ Reeders Run Rd. Mark Major made a motion to accept. Motion seconded by Mark Werkeiser. All voted aye. Motion carried.

Comments:

State Police Coverage:

Jackson Township resident, Steve Paige, addressed the Board of Supervisors concerning the possibility of Jackson Township having to pay for State Police coverage in the future. Steve Paige inquired if Jackson Township had a plan in the event this occurs. Mark Major stated Jackson Township is not currently researching, but has been in touch with surrounding Townships. Todd Weitzmann advised this was proposed, but not accepted or approved. Mark Werkeiser advised Mr. Paige to attend a CJERP meeting (held last the Thursday of each month at Chestnuthill Township building). CJERP has been discussing various options.

PPL Electric Power Upgrade Project:

PPL Electric Company has requested an easement on Rinker Road for pole and line replacement. PPL is requesting an easement of 25ft. on either side of the proposed powerline. Upon review of the plan and maps provided by PPL, Todd Weitzmann advised this may encroach on Township property largely and the placement of the poles may also restrict future property usage and accessibility. Mark Major made a motion to table the decision pending further clarification from PPL on their plans. Motion seconded by Mark Werkeiser. All voted aye. Motion carried.

There being no further business, Mark Major made a motion to adjourn. Motion seconded by Mark Werkeiser. All voted aye. Motion carried. Meeting adjourned at 7:35 PM.
